OR TRANSACTION; THE DISINTERESTED MEMBERS OF THE BOARD OF DIRECTORS MAY
APPROVE THE PROPOSED ACTION OR TRANSACTION UPON FINDING THAT IT IS IN THE
BEST INTEREST OF THE CORPORATION. THE BOARD SHALL CONSIDER WHETHER THE

IF AFTER HEARING THE RESPONSE OF THE INTERESTED PARTY AND MAKING SURE FURTHER INVESTIGATION AS MAY BE WARRANTED IN THE CIRCUMSTANCES, THE BOARD DETERMINES THAT THE INTERESTED PARTY HAS IN FACT FAILED TO DISCLOSE AN ACTUAL OR POSSIBLE CONFLICT OF INTEREST, IT SHALL TAKE APPROPRIATE DISCIPLINARY AND CORRECTIVE ACTION.
